# The Transfer charges are based on the allotment cost in the year which it was allotted by the authority.

Flats allotted in or before 1990, transfer charges are 50% of the allotment cost.

Flats allotted between 1991 to 2000, transfer charges are 20% of the allotment cost.

Flats allotted in or after 2001, transfer charges are 10% of the allotment cost.

Flats allotted in or after 2011, transfer charges are 05% of the allotment cost.

Transfer charges for Shramik Kunj are Rs. 12,000/-

The minimum transfer charges of EWS flats is Rs. 34,000/-; LIG Flats Rs. 69,000/-; MIG Flats Rs. 1,15,000/-; and HIG Flats Rs. 1,70,000/-

# **NOTE:** on Circle rates:

- The facility of 1.)Swimming Pool 2.) Club/Community Center 3.)Gym 4.)Power Backup 5.) Passenger lift attracts appreciation in circle rate @ 3% for each facility upto a maximum of 15% if all facilities are available.
- Circle rate will be calculated on the whole super area (system of common area stands abolished in the new list). The m minimum common area is to be added as 20%.
- The Circle rates are for Ground floor to Third floor flats. The Transferee will get Deduction of 2% on every floor starting from Fourth floor and above subject to a maximum of 20% deduction.
- Circle rate of Single unit/Duplex flats will be calculated as per the land rate in the concerned sector and the rate of construction applicable.
- Circle rate of Two Floor apartment/flats will be calculated as 50% of the current circle rate of land in the concerned sector and the 100% of rate of construction applicable.
- Circle rate shall be Rs. 1,50,000/- for the open parking and Rs. 3,00,000/- for the Garage/Covered parking. Scooter Parking Rs. 75,000/-
- Stamp Duty Calculation: Basic rate + Facilities Floor Discount + Parking x 5%
